



Memorandum of Understanding on Two Way Investment Promotion Cooperation

The Chilean Foreign Investment Committee and Invest Hong Kong, the Government of Hong Kong Special Administrative Region (here-in-after referred to as 'both parties') reaffirm the existing strong cooperative relationship in two-way investment promotion.

The objective of this Memorandum of Understanding shall be to help the Parties to promote, within the bounds of their own competence, an attractive and stable reciprocal investment climate.

The parties will jointly promote the smooth information exchange on the following:

- Investment environment;
- General Information on investment opportunities;
- Investment promotion activities; and
- Experiences in attracting foreign investment and best practices investment promotion

Both parties will also refer outward opportunities for local companies interested in setting up or expanding their businesses in Chile and Hong Kong and support inward investments, referred by the partner agency.
