## Memorandum of Understanding on Two Way Investment Promotion Cooperation

The Chilean Foreign Investment Committee and the Japan Institute for Overseas Investment (here-in-after referred to as 'both parties') reaffirm the existing strong cooperative relationship in two-way investment promotion.
